One Month from the date of cancellation of admission
3	A candidate desirous to withdraw his candidature after completion of admission on vacant seats, for any reason whatsoever, shall have to request in writing in person to the college or institution in which he is granted admission.	He shall not be entitled to get refund of the fees paid by him for getting admission. In that case he may get only deposit as refund.	One Month from the date of cancellation of admission
